What does the Property Institute provide?


Continuing Professional Development – CPD enhances the quality and skills of the profession through accreditation of university courses, online learning modules, seminars and conferences. Our national events take the form of face to face sessions and workshops, and online webinars and modules.

Networking – Our branch network (16 across the country and one in London) and 4 Professional Communities provides constant support for members and an opportunity to discuss relevant industry topics with fellow members and guest speakers both at national and local level.

www.property.org.nz – Our informative website targets both members and the public. Members can access current and historic industry news, events and can advertise their services. The public are able to search for members using the 'Find a Property Professional' tool. The Property Voice section of the website also features commonly asked questions relating to topics such as buying a home and valuation.

Conferences – Our annual conference is a much anticipated event. The conference boasts well renowned speakers who share their expertise with the membership.



Publications – Members are kept up to date with industry news via the Australia and New Zealand Property Journal and our in-house weekly and quarterly e-newsletters.

JOBMail – A weekly email service to members advertising any current positions available and some positions sought. The listings are also available for members to view on the Institute's website.

Property Registration – An added status conferred by the Property Institute of New Zealand Board in the occupational streams of Plant and Machinery Valuation, Property Consultancy, Property Management and Facilities Management. The Valuers Registration Board registers Property Valuers.

Property Standards – These set the standards of practice in New Zealand.

The Institute has had and continues to have considerable input into the development of International Valuation Standards also.

Code of Ethics and Discipline – These are enforced by a Professional Practice Committee to ensure that the public are served ethically and are protected.

Awards – The Institute promotes professionalism and recognises excellence annually by providing national and tertiary studies awards.

Membership Discounts – As part of their membership package, members are entitled to substantial discounts on a number of products and services ranging from fuel cards to insurance, to monthly telephone plans. Not to mention free use of the national office's boardroom for meetings, and reduced price access to our audio conferencing service.



International Relationships – The Institute has a number of reciprocity arrangements with other countries that have regulated professional market places, allowing New Zealand members to practice overseas more easily. In addition, the Institute has a strategic alliance with the Australian Property Institute. We are also represented on other international bodies such as IVSC (International Valuation Standards Committee), WAVO (World Association of Valuation Organisations), PPC (Pan Pacific Congress of Real Estate, Appraisers, Valuers and Counselors), PRRES (Pacific Rim Real Estate Society), and has a number of other international relationships.

Library Services – Our R J Maclachlan library consists of a range of publications on all aspects of the property profession which are available to members. The library is on site, and members are welcome to browse at their leisure or borrow publications as required. We also have a number of publications available to purchase at discounted member prices.

Future Property Professionals – The Institute is forward-looking, energetic and recognises the vital role and importance that younger members of the profession will play. It enjoys a close relationship with tertiary providers of property degrees and their students. These tertiary providers consist of Lincoln, Massey, Auckland and Unitec universities. With over 600 student and graduate members, the Institute works actively with the universities to ensure the students' careers in property are supported appropriately. This support includes:

- Awards and scholarships for students
- Support and sponsorship of graduation dinners, award ceremonies and "buddy evenings"
- Providing an annual graduate induction seminar for recent property graduates
- Developing the professional pathways programme for practical professional development post university study
- Accrediting university courses to ensure they meet industry requirements

The Institute also promotes property as a career through secondary schools. This is achieved by using 'School Packs' which were sent to schools nationwide and introduced the Institute and property careers to students.

Membership Categories

As a property professional there are several membership options available throughout a member's career;

Student/Graduate Membership - Open to anyone who is currently studying/has recently completed a Property Institute accredited qualification.

Affiliate Membership – Open to anyone who is actively involved in providing professional services to the property industry (a Property Institute accredited qualification is not required).

Full Member (MPINZ) – Open to any member who has been employed in the property profession for at least two years, and complied with the Institute's CPD requirements for a minimum of two years, including an ethics module.

Registered Member – Open to any member who has been MPINZ for 12 months, resident and practicing in New Zealand and who is fully compliant with CPD requirements.

Senior Member (SPINZ) - Open to any member who has 8 years post graduation experience and achieved registration either with the VRB or the Property Institute.

Fellow (FPINZ) – A member may be nominated for Fellowship of the Institute if they are deemed to have attained a significant professional standing. This includes recognition for services to the industry and to the Institute over an extended period. Nomination is from one of the Institute's Branch Committees. Fellowships are awarded at the discretion of the Institute's Board of Directors

Life FPINZ (Life) – Is awarded to Fellows of the Institute who have rendered pre-eminent service over an extended period to the industry and Institute. It is awarded by election from the Institute's Board of Directors
